OCTOBER 18, 2017

CALL TO ORDER

Mayor Byrd called the meeting to order at 7:00 p.m.

Mayor Byrd read the OPMA Statement into the record as follows:

OPEN PUBLIC MEETINGS ACT STATEMENT

This meeting of the Fairfield Township Committee shall come to order. The New Jersey Open Public Meeting Law was enacted to insure the right of the public to have advanced notice of and to attend the meeting of the public bodies at which any business affecting their interests are discussed or acted upon. This meeting held on this 18th day of October 2017 at the Fairfield Municipal Building in Fairton New Jersey is held pursuant to notice of date, time and place of same having been submitted to The South Jersey Times, The Daily Journal, and The Press of Atlantic City on January 11, 2017 and also duly posted on the bulletin board in the lobby of the Township Hall.

A CAPITAL ORDINANCE PROVIDING FOR IMPROVEMENTS AND/OR REPAIRS TO VARIOUS MUNICIPALLY OWNED PROPERTIES AND ACQUISITION OF SHELTER FOR CONVENIENCE CENTER AND APPROPRIATING THEREFOR THE AMOUNT OF \$22,500.00 FROM THE CAPITAL IMPROVEMENT FUND

Mayor Byrd announced into the record that tonight we will conduct the public hearing for comments to be received, however, the Township Committee will not be adopting Ordinance No. 9 – 2017 tonight as it requires a 2/3 affirmative votes of the full membership of the governing body for final adoption. The public hearing was advertised as prescribed by law and the second reading for final adoption will be placed on the November 1, 2017 agenda.

Committeeman Manson moved to close the public hearing seconded by Committeeman Clark. Roll Call Vote: Clark, yes; Manson, yes and Mayor Byrd, yes.

Mayor Byrd asked the Township Clerk to explain said resolution into the record.

Township Clerk Gonzales explained the currently pending 2 bills before the State Legislators, one which would revise the Open Public Meetings Act and one that that would revise the Open Public Records Act. The Clerk advised that both of these bills have been opposed by both the New Jersey League of Municipalities and the New Jersey Municipal Clerk's Association and respectfully request that this resolution be supported by the Fairfield Township Committee.

Ms. Ridgway indicated that the governing body should support the opposition of these two (2) proposed amendments.

There being no further comments to be received. Mayor Byrd entertained a motion to close the meeting for Public Comment on Current Agenda & Non Agenda Items.


There was no need for an Executive Session tonight.
