

**ORDINANCE NO. 9 - 2017**  
**TOWNSHIP OF FAIRFIELD**

---

**A CAPITAL ORDINANCE PROVIDING FOR IMPROVEMENTS AND/OR REPAIRS TO  
VARIOUS MUNICIPALLY OWNED PROPERTIES AND ACQUISITION OF SHELTER FOR  
CONVENIENCE CENTER AND APPROPRIATING THEREFOR THE AMOUNT OF \$22,500.00  
FROM THE CAPITAL IMPROVEMENT FUND**

---

**BE IT ORDAINED** by the Township Committee of the Township of Fairfield, County of Cumberland and State of New Jersey (not less than two-thirds of all the members thereof affirmatively concurring) as follows:

Section 1. The improvements and acquisitions described in Section 2 of this Ordinance are hereby authorized to be made by the Township of Fairfield, County of Cumberland, State of New Jersey and there is hereby appropriated the sum of Twenty-Two Thousand, Five Hundred (\$22,500.00) Dollars from the Capital Improvement Fund, said amount now being available therefor in the General Capital Account of the Township of Fairfield.

Section 2. The improvements and acquisitions hereby authorized are:

- (a) Replacement of main Heating and Air Conditioner Compressor and repairs to same at the municipal building together with all work and materials necessary therefor or incidental thereto.
- (b) Repairs to septic system at municipal building together with all work and materials necessary therefor or incidental thereto.
- (c) Repair and replacement of Sewage Injector Pumps at the municipal building together with all work and materials necessary therefor or incidental thereto.
- (d) Repair to potable water well system and replacement of bladder tank to supply water to Senior Center together with all work and materials necessary therefor or incidental thereto.
- (e) Acquisition and installation of Shelter for employees at the Township Convenience Center together with all equipment, work and materials necessary therefor or incidental thereto.

Section 3. The said purposes described in Section 2 of this Ordinance are not current expenses and are improvements which the Township may lawfully make, under the provisions of N.J.S.A. 40A:2-1, *et. seq.* (Local Bond Law).

Section 4. This Ordinance shall take effect following its advertisement, public hearing and adoption in accordance with the requirements of law.
