FAIRFIELD TOWNSHIP COMMITTEE REGULAR ACTION MEETING VIA TELECONFERENCE JUNE 16, 2021

CALL TO ORDER

Mayor Benjamin Byrd, Sr. called the meeting to order at 6:00 p.m.

Mayor Byrd read the OPMA statement into the record as follows:

This meeting held on this 16^{th} day of June 2021via teleconference is held pursuant to notice having been submitted to The South Jersey Times, The Daily Journal, and The Press of Atlantic City on January 11, 2021 and also duly posted on the Township website.

Charles Fiore, Marmero Law, LLC standing in for Township Solicitor Al Marmero, Marmero Law, LLC indicated into the record that the three (3) committee members present at tonight's meeting constitutes a quorum, however Mayor Byrd works South State, Incorporated and the son of Committeeman Tommy Clark, Jr. is employed for South State, Incorporated of which a conflict exists and the Resolution cannot be passed at this time. He recommended that either the Township Committee may want to schedule a Special Meeting or table until the next scheduled meeting in order to have the proper amount of votes for the Resolution to be passed and adopted in this matter.

Mayor Byrd entertained a motion to table the renewal application for South State, Incorporated to the next scheduled meeting.

Committeeman Tommy Clark, Jr. moved to table Resolution No. 99 - 2021 seconded by Deputy Mayor Marvin Pierce, Jr. Roll Call Vote: Committeeman Tommy Clark, Jr., yes; Deputy Mayor Marvin Pierce, Jr., yes and Mayor Benjamin Byrd, Sr., yes.

RESOLUTION NO. 100 - 2021

ADOPTION OF 2021 MUNICIPA BUDGET

Mayor Byrd announced that the budget was introduced on March 17, 2021 and a Public Hearing was held on April 21, 2021. As indicated at both the introduction and public hearing, the budget is a zero tax increase. Mayor Byrd asked the Township Committee if they had any questions. There were none.

Being there were no questions, Mayor Byrd entertained a motion to adopt.

Committeeman Tommy Clark, Jr. moved to adopt Resolution No. 100 - 2021 seconded by Deputy Mayor Marvin Pierce, Jr. Roll Call Vote: Committeeman Tommy Clark, Jr., yes; Deputy Mayor Marvin Pierce, Jr., yes and Mayor Benjamin Byrd, Sr., yes.

OLD BUSINESS

Committeeman Tommy Clark, Jr. had no Report Business to report.

Deputy Mayor Marvin Pierce, Jr. had no New Business to report.

At this time, Mayor Byrd gave the floor under New Business to Howard Melincove, attorney representing South State, Incorporated.

Howard Melincove entered into the record and advised that he is the attorney for South State, Incorporated regarding the application that was presented to the Township Committee for the renewal of the license mining permit for South State operational on Reeves Road. He indicated as the Township Committee is aware, in 2016 this type of application is a two (2) step process, the first goes before the

Planning & Zoning Board for essential a technical review of the new mining plan and the second step after the Planning & Zoning Board is to come before the Township Committee for the actual issuance of the renewed permit. He advised that as he indicated in the materials that they had presented along with their application for the permit renewal before the Township Committee, they presented the proof of the fact that they appeared before the Planning & Zoning Board earlier this year and that the Planning & Zoning Board approved the new mining permit and was memorialized it by a Resolution of April 13, 2021 of which they have presented. He advised that is way they are here before the Township Committee.

Mr. Melincove indicated that if the Township Committee recalls the same thing happened under the new mining ordinance when South State, Incorporated appeared before both the Planning & Zoning Board and the Township Committee in 2016 and advised this a renewal that they will do every 5 years as required under the new mining ordinance.

Mr. Melincove advised that they do understand of course of the issue of conflicts of interest and that they do understand also that the Township Committee would need at least a minimum of a quorum for this to move forward and that he appreciates that was not available this evening. He advised that there were two (2) points that he wishes to make and not in the merit of the application but just an understanding how they will now proceed procedurally with this matter. He stated the first is that they do have all the materials in with the accordance with the mining ordinance and that is by the letter that they had received from the Township's Engineer, James Winckowski dated June 11, 2021 all of which is in front of the Township Committee. He stated that being said, they appreciate the fact obviously that you come up with no prejudice to the continuation of the mining operation by South State, Incorporated and that he just wanted to put this out on the record and that South State, Incorporated will continue with the mining operation even though this matter is now pending in front of the Township Committee. The second point that Mr. Melincove and something that the Township Committee would like to discuss is that it may be difficult to achieve for a quorum on this application because of a number of conflicts that we have experienced in the past with South State, Incorporated such as with Mayor Byrd of which he is not an employee of South State, Incorporated but rather an independent contractor who contracts services with South State, Incorporated and so at some future date perhaps at the next month's meeting date that will be held in July even if there are members that have conflicts, there may be coming a point in time where the Doctrine of Necessity will have to be invoked in order for there to be a quorum and allow this to move forward. Mr. Melincove advised that the Township's Solicitor can explain what the Doctrine is and that at some point and time even a member who has a conflict may be called upon to vote on this application simply because the applicant is entitled to action and a quorum.

Mayor Byrd advised Mr. Melincove that the Township Committee does understand the Doctrine of Necessity. He stated that the Township Committee had a couple of members who could not make tonight's meeting and that he is hoping that the members can make it to the meeting in July.

Mr. Melincove stated that South State, Incorporated certainly appreciates the fact that sometimes members are not able to attend a meeting and that is fine. He advised that he will continue to be in touch with the Township Clerk and with the Township Administrator to see where we are in the form of conflicts and a quorum so that we can move this matter along as rapidly as possible.

TOWNSHIP COMMITTEE REPORT / REMARKS

Deputy Mayor Marvin Pierce, Jr. gave thanks to everyone that attended tonight's meeting.

Committeeman Tommy Clark, Jr. echoed Deputy Mayor Marvin Pierce, Jr. remarks and to continue to be safe.

MAYOR'S REPORT / REMARKS

Mayor Byrd thanked everyone that attended tonight's meeting and to continue to be safe and that he also wanted to take a moment to thank the Township Committee for putting their work in. He stated that understands some of the members are not present tonight but that for the members that are present tonight he thanked them and for the work they put in another zero tax increase in the budget.

Mayor Byrd stated that for five (5) years in a row, Fairfield Township has been a zero tax increase which is unheard of in some municipalities and still being able to operate.

Nancy Ridgeway, 582 Irving Avenue wishes everyone well. She thanked the Township Committee for finally approving the 2021 Municipal Budget so that the tax bills can go out in time and that she is really excited about it. She wished everyone a nice 4th of July and for everyone to stay safe.
