### FAIRFIELD TOWNSHIP COMMITTEE ACTION MEETING MINUTES September 17, 2013 7:00 PM

### CALL TO ORDER

Mayor JoAnne Servais called the meeting to order and read the OPEN PUBLIC MEETINGS ACT statement at 7:00pm.

### SALUTE TO THE FLAG

Mayor JoAnne Servais led the Flag Salute.

### ROLL CALL

All Committee Members present except for Committeeman Morton who was excused.. Doug Burry Esq. was in for George Saponaro.

### **PRESENTATIONS**

Michelle Behm, Tax Assessor, went over qualifications for a Qfarm and how the assessment for a Qfarm property is calculated. She said currently there are 158 Qfarms. She said in order for a property to qualify, the property has to be a minimum of 5 acres and actively farmed for 2 years. She said a home cannot be attached to the property and that proof of income from farming has to be submitted every year. She said the applicants must re-apply every year by August 1st. She also said the state gives an average value each year and that value is multiplied by the total number of acres to get the total assessed value of the Qfarm.

### **SOLICITOR'S REPORT** – Doug Burry, Esq.

The Solicitor had nothing to add from his report from the previous week.

### **ENGINEER'S REPORT** - Fralinger Engineering

The Engineer submitted a written report.

### ADMINISTRATOR'S REPORT – Leo Selb

The Administrator reported that all the wells at the municipal building were properly chlorinated. He also reported there was a blockage at the sewer station. He also said he received a quote for the Senior Center ramp and there were questions about getting a architectural drawing. He said he would check with the Construction Office. He also said the demolition on Buckshutem Road is moving forward. He also said the report on the landfill been filed. He said there is no cost until the Engineer meets with the DEP. He said fire prevention week is coming soon and Fire Company #2 requested assistance with refreshments. He talked about the Township's roll off truck being down and in the past the Township used the Federal Prison's roll off. However due to a change in Administration something needs to be drafted in writing to give to the prison so the service can continue. Committeeman Sharp asked if the County had been asked. Deputy Mayor Thomas-Hughes agreed and asked if the Committee could vote tonight to have an agreement prepared.

### Resolution #125-2013

Deputy Mayor Thomas-Hughes motioned to authorize the Solicitor to draft a shared services agreement for Federal Prison for use of the roll-off truck.. Committeeman Taylor seconded the motion.

The Administrator also mentioned there would be work done on the railroad crossing at Fairton - Gouldtown and Fairton-Millville Road. He also talked about possibly doing a shared service with the County for hot lunches for the Senior Center. He also again commented that the landfill was moving along. Committeeman Sharp asked what line item the money would come from out of the budget. The Administrator reminded the Committee they had passed an emergency resolution to for the funding up to \$90,000.

### **NEW BUSINESS**

The Mayor mentioned sending a letter to the school and the sidewalks would be taken care of by the school.

The Special Event permit for La Mexicana was discussed. Mr. Felipe Matias, Jr. spoke on behalf of the event. He said he believed the bass is the issue and that it would be turned down. He said that they are doing their best to comply. Mayor Servais mentioned she attended the last event they had and someone complained about the noise and they did turn it down.
