PUBLIC HEARING / 2024 MUNICIPAL BUDGET

NEIL YOUNG, CHIEF FINANCIAL OFFICER

NANCY SBROLLA, MUNICIPAL AUDITOR, FORD SCOTT & ASSOCIATES

Neil Young, Chief Financial Officer reported that the 2024 Municipal Budget is a \$4 million budget that is inclusive of the Township grants. The budget is under the Appropriation CAP, under the Tax Levy Cap and the budget comes with a 1 cent tax increase. As previously discussed, he reported that the Township has not had a tax increase in 5 to 6 years and kudos for doing a wonderful job in keeping it down for our taxpayers, therefore tonight is the Public Hearing and then adoption of the 2024 Municipal Budget.

Nancy Sbrolla, Municipal Auditor approached and advised that as the Chief Financial Officer reported there have been no amendments to the budget that was introduced last month and that we are still at a 1 cent tax increase. She stated that the Township Committee and the Chief Financial Officer did a wonderful job of keeping everything where it should be.

She reported that the Township is in good financial shape and this budget will keep us there. She reported that last year about \$1.7 million dollars in surplus and that we are using about \$400,000 which is consistent in what we have been using and making back and it is a very responsible budget.

The Township Committee thanked Neil Young and Nancy Sbrolla.

There being no questions from the Township Committee, Mayor Pierce entertained a motion to open the Public Hearing.
