STATE OF NEW JERSEY FIXING THE SALARIES AND/OR WAGES OF CERTAIN  
OFFICERS AND EMPLOYEES

WHEREAS, the Township of Fairfield employs certain officers and employees; and,

WHEREAS, the Township of Fairfield from time to time is required to establish and determine the range of salaries and/or wages for those officers and employees;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Fairfield, County of Cumberland, State of New Jersey that the following salary and/or Wage Ordinance is hereby established.

**Section Two. Severability.** If any part or parts of this ordinance are held to be invalid for any reason such decision shall not affect the validity of the remaining portions of this ordinance.

**Section Three.** This ordinance shall be effective after final approval and publication as required by law, except for the salaries of the Chairman of the Township Committee and the Members of the Township Committee which shall take effect in accordance with the provisions of N.J.S.A. 40A:9-165.




