The Regular Action Meeting of the Township Committee of Fairfield Township was held on May 21, 2025 at 6:00 p.m. in the Committee Chambers Room, 70 Fairton-Gouldtown Road, Fairton, New Jersey 08320 with Mayor Marvin Pierce, Jr. presiding.

## PUBLIC HEARING / 2025 MUNICIPAL BUDGET

Neil Young, Township Chief Financial Officer and Nancy Sbrolla, Municipal Auditor with Ford, Scott & Associates were present for the Public Hearing on the 2025 Municipal Audit.

Neil Young reported that the Township Committee introduced the 2025 Municipal Budget in early April.

The 2025 Municipal Budget is a \$3.44 million dollar budget and comes with a 4.5 cent tax increase to the municipality. He advised that the Township has done great with taxation and that there were only two (2) tax increases in the last 8 years. He advised that the 4.5 cent tax increase is only \$18.00 per quarter to the average residential property owner in the township.

He reported that some of the items that were affecting the budget were loss of municipal relief aid; Fairfield Township Convenience Center is up to \$14,000.00; Animal Control Services is up \$7,000.00; Health Benefits are up \$27,000.00 and Debt Services up \$40,000.00, therefore, that is what this tax increase is needed.

Neil Young, stated the next step is to have a Public Hearing so that if a member of the public would like to speak, they can and after the Public Hearing, there is an Amendment that has been prepared based upon the State Review that we previously had and that it is increasing the Township's State Aid slightly and

increasing the Township's Surplus and once the Amendment Resolution is adopted, the Township Committee can adopt the Amended Budget.

Neil Young asked Municipal Auditor Nancy Sbrolla if she had anything to add and she indicated that the Chief Financial Officer had covered everything.

At this time, Mayor Pierce entertained a motion to open the Public Hearing on the 2025 Municipal Budget.
